Ruffini reviewed the minutes from the prior meeting. A motion to approve the consent agenda was made by Uram and seconded by Whitley. The motion passed unanimously.

Ruffini stated the the events venue opens next week. The project is still slightly under budget, there will be work remaining to accomplish later in the spring/summer including

replacement of the east patio and stairs, landscaping, a new outdoor art installation, a new name for the venue will be announced in the coming weeks, and work to begin booking the venue will start to occur. A total of \$20,000 has been budgeted in rental revenue this year. Ruffini then discussed the latest with the Beloit Kubb Open which will take place on August 9 at Pohlman Field. Details and registration can be found at visitbeloit.com/kubb. Ruffini noted that he will be applying for grants to assist with public art installations in the community, as well as has committed to work with the Downtown Beloit Association and the Beloit Art Center on more vinyl utility box wraps. The organization won an award from the Downtown Beloit Association recently because of the investment we made into the vinyl wraps in 2024.

Ruffini commented that the \$71,000 budgeted transfer from Visit Beloit, Inc. to this organization has occurred, the sponsorships to the Beloit International Film Festival and Friends of the RiverFront have been paid for the year, 50% of the Beloit Sky Carp sponsorship has been paid and a new contract will be negotiated beginning in 2026, the organization will continue to advocate for grant applicants, it is likely that the exploration of creating at 501(c)(2) organization will occur this year which will affect the structure of who owns our property, and lastly, Whitley's term ends in 2025 and a new chair along with a new board member will need to be considered.
