#### Minutes for Visit Beloit, Inc. Board of Directors July 2025 Meeting

Phalin thoroughly reviewed the audit presentation notes regarding the FY2024 audit, as well as covered the additional letters and statements that resulted from the audit. The audit was conducted without any disagreements with the organization's management and no points, or findings for improvement, were issued this year. Ruffini also noted that he included the Form 990's for both organizations, as well as the Form 1952 for review which are documents that get filed with the federal and/or state government. Phalin commented that they have one year remaining on their current services agreement with our organizations. No significant questions pertaining to the audit were asked of Phalin.

Additionally, the board reviewed the minutes from the prior board meeting. A motion was made to approve the consent agenda by Keraka and seconded by Pennington. The motion passed unanimously.

Moreover, Bliss notified Ruffini of her resignation recently after four years with Visit Beloit as she has accepted a new position with Meridian. Ruffini has been working on changing some role descriptions and posted the job vacancy across multiple platforms last week.
